Whereas, the Allocations Manual provides policies and procedures guiding the Allocations process and is intended to inform student organizations about the SGB Allocations Process,

Whereas, the Allocations Manual has not been revised for clarity and accuracy in many years,

Whereas, the SGB Governing Code was created to house all bylaws, codes, policies, and manuals of Student Government Board in one comprehensive document,

Whereas, the SGB Governing Code currently does not contain the Elections Code, the Judicial Committee Bylaws, the Elections Committee Bylaws, or any conditional committees,

Whereas, the Board has spent several months reviewing policies and procedures, revising language, and reformatting the SGB Governing Code so it can be better understood and will improve the operations of Student Government Board,

THEREFORE BE IT RESOLVED, on this 11th day of November in the year of 2014, the Student Government Board at the University of Pittsburgh in partnership with the Allocations Committee enacts the following clarifying and consolidating amendments to Chapter 2 of Title 3 of the SGB Governing Code called The Allocations Manual. With the approval of the Allocations Committee Chair and the Board these revisions shall reflect the changes summarized below:

Summary of B-024: Part I – The Allocations Manual

- Removal of Panther Prints, Telefact, and Student Volunteer Outreach
- Addition of the Office of PittServes and the Student Office of Sustainability
- Clarification of the budget submission and hearing process
- Addition of the funding release process
- Chair discretion for requests for additional expenses
- Clarification on request postponements

- Additional Clauses for:
 - Other Competitive Organizations
 - Academic and Professional Student Organizations
 - Funding for all other categories

BE IT FURTHER RESOLVED, that Student Government Board enacts the following policy changes and amendments to the SGB Governing Code. With the approval of the Board, these revisions shall reflect the changes summarized below:

Summary of B-024: Part II – The SGB Governing Code

- Addition of:
 - Title 4: The Judicial Committee
 - Title 5: The Elections Committee
 - Title 6: The Assembly
 - Title 7: Student Organization Code
 - Title 8: Student Services Provided by SGB
- Revisions to:
 - Title 1: Student Government Board
 - Title 2: The Board

BE IT FINALLY RESOLVED, the amended SGB Governing Code in its entirety shall read as it does in the attached document Appendix A and shall be effective immediately upon adoption by Student Government Board.
