# A BILL

REINTRODUCING THE GREEN FUND ADVISORY BOARD CHARTER

1 WHEREAS, Student Government Board previously established the  
2 Green Fund Advisory Board to promote and assist  
3 students with sustainability ideas on campus;  
4 WHEREAS, the Green Fund Advisory Board Charter was  
5 inadvertently dropped from the Student Government  
6 Board Governing Code during the reorganization  
7 carried out by Bill 024;  
8 WHEREAS, President Meyer tasked the Judicial Committee with  
9 reviewing all 2014 amendments to the Student  
10 Government Board Governing Code and the  
11 Committee has recommended that the Board introduce  
12 a bill to formally reestablish the Charter; *now,*  
13 *therefore, be it*

- 14 RESOLVED, on this 24<sup>th</sup> day of March in the year 2015, the  
15 University of Pittsburgh Student Government Board  
16 enacts the following revisions to the Student  
17 Government Board Governing Code under the short  
18 title “Confirmation of the Green Fund Advisory Board  
19 Charter”; *and be it further*
- 20 RESOLVED, that the Green Fund Advisory Board Charter shall  
21 read as it did after the Bill 022 was passed with no  
22 additional changes; *and be it further*
- 23 RESOLVED, that all numbering changes resulting from these  
24 revisions shall be automatic, pursuant to the rules set  
25 forth in items 1.1.1.0.4 and 1.1.1.0.5 of the Student  
26 Government Board Governing Code; *and be it finally*
- 27 RESOLVED, that this resolution shall be effective immediately  
28 upon adoption and shall reflect the changes shown in  
29 the attached document.
- 30 ADOPTED: this [14<sup>th</sup> day of February 2015] by a vote of [8] for, [0]  
31 against, and [0] abstentions.
