## A BILL

PREVENTING SGB BOARD MEMBERS AND ALLOCATIONS COMMITTEE  
MEMBERS FROM SUBMITTING OR DEFENDING ALLOCATIONS REQUESTS

1 WHEREAS, board members and allocations members are required  
2 to regularly exercise their judgement regarding the  
3 approval of allocations requests;  
4 WHEREAS, recusal would aid in the assurance of a fair and  
5 balanced allocations process;  
6 WHEREAS, the University of Pittsburgh Student Government  
7 Board practices impartiality and fair judgement on  
8 principle; *therefore be it*  
9 RESOLVED, on this 8<sup>th</sup> day of November in the year 2016, the  
10 University of Pittsburgh Student Government Board  
11 enacts the following revisions to the Student  
12 Government Board Governing Code under Chapter 2,  
13 Article 2, Section 1, Item 3 “General Submission

14 Requirements for Both Supplemental and Budgets”;  
15 *and be it further*

16 RESOLVED, that the following changes be made to the Governing  
17 Code:

- 18 • Within Article 2, Section 1, Item 3, add item C  
19 “Any allocations requests that are made by a  
20 sitting Board Member or Allocations Committee  
21 Member will not be accepted.”;
- 22 • Within Article 2, Section 1, Item 3, add item D  
23 “A formal defense of any request, be it public or  
24 private, cannot be made by a sitting Board  
25 Member or Allocations Committee Member .”;

26 *and be it further*

27 RESOLVED, that all numbering changes resulting from these  
28 revisions shall be automatic, pursuant to the rules set  
29 forth in items 1.1.1.0.4 and 1.1.1.0.5 of the Student  
30 Government Board Governing Code; *and be it finally*

31 RESOLVED, that this resolution shall be effective [immediately  
32 upon adoption] and shall reflect the changes shown in  
33 the attached document.
