CHANGING THE STRUCTURE OF PUBLIC MEETING TO ADD AN ADDITIONAL  
OPEN FLOOR TO THE BEGINNING OF PUBLIC MEETING

- 1 WHEREAS, the University of Pittsburgh Student Government  
2 Board serves as the collective voice of the  
3 undergraduate student body;
- 4 WHEREAS, SGB wishes to increase student feedback and  
5 involvement;
- 6 WHEREAS, the current structure of public meeting does not allow  
7 for easy student feedback; *now, therefore, be it*
- 8 RESOLVED, on this ~~[18th day of April in the year 2017]~~, the  
9 University of Pittsburgh Student Government Board  
10 enacts the following revisions to the Student  
11 Government Board Governing Code:
