A RESOLUTION

UPDATING THE BYLAWS OF THE ASSEMBLY

- 1 WHEREAS, The Assembly is meant to create a forum of
2 collaboration and networking among student
3 organizations on campus;
- 4 WHEREAS, The Bylaws of the Assembly are meant to clearly
5 outline the purpose and procedures of this legislative
6 body;
- 7 WHEREAS, The Student Government Board wishes to have non-
8 Presidential delegates from Student Affairs Affiliated
9 Groups in order to increase the activity of these
10 organization members with Student Government
11 Board and to avoid conflict with the SAAG Presidents
12 Council;
- 13 WHEREAS, Student Government Board wishes to be inclusive of
14 all gender identities; *now, therefore, be it*

15 RESOLVED, on this 10th day of November in the year 2016, the
16 University of Pittsburgh Student Government Board
17 suggests the following changes to the Assembly
18 bylaws:

20 Item 6.1.2.2.1.F shall be added and shall read “SAAG
21 Presidents may not serve as a delegate or as an
22 alternate to the Assembly.”

23

24 Item 6.1.2.4.1.A shall now read “...attend the
25 Assembly meetings set during the first and third
26 weeks of each month at a time designated by the
27 Speaker.”

28

29 Item 6.1.2.4.3.B shall have a comma added after the
30 word “member”

31 All instances of the use of any variation of a gendered
32 pronoun shall be changed to the appropriate version of
33 “they/their/theirs” followed by the appropriate
34 grammatical changes; *and be it further*

35 RESOLVED, that the above changes will be voted on at the next
36 meeting of the Assembly; *and be it finally*

37 RESOLVED, this resolution shall be effective immediately upon
38 adoption and shall reflect the official position of the
39 University of Pittsburgh Student Government Board.

40 ADOPTED: this 10th day of November 2016 by a vote of 8 for, 0
41 against, and 0 abstentions.
