A BILL

UPDATING THE SELECTION PROCESS OF STUDENT GOVERNMENT BOARD
REPRESENTATIVES TO THE UNIVERSITY SENATE COUNCIL

- 1 WHEREAS, one of the purposes of the Student Government Board
2 is to stimulate and facilitate communication and
3 interaction between the members of the student body
4 and university community;
- 5 WHEREAS, this is accomplished in part with Student Government
6 Board appointing representatives to various
7 University committees, including the Senate Council;
- 8 WHEREAS, the Senate Council serves as the official body of shared
9 governance at the University;
- 10 WHEREAS, the positions of Vice President & Chief of Finance and
11 Vice President & Chief of Cabinet have only existed for
12 three administrations; *now, therefore, be it*
- 13 RESOLVED, on this 13th day of March in the year 2018, the
14 University of Pittsburgh Student Government Board

- 15 enacts the following revisions to the Student
16 Government Board Governing Code:
- 17 Item 2.1.2.0.1 Amend sub-section B and add “4. serve as a
18 representative to the University Senate Council”.
- 19 Item 2.1.3.0.1 Amend sub-section A and add “8. serve as a
20 representative to the University Senate Council”.
- 21 Item 2.1.4.0.1 Amend sub-section A and add “6. serve as a
22 representative to the University Senate Council”.
- 23 Item 2.1.5.0.1 delete sub-section B in full; *and be it further*

- 25 RESOLVED, that all numbering changes resulting from these
26 revisions shall be automatic, pursuant to the rules set
27 forth in items 1.1.1.0.4 and 1.1.1.0.5 of the Student
28 Government Board Governing Code; *and be it finally*
- 29 RESOLVED, that this bill shall be effective immediately upon
30 adoption and shall reflect the changes shown in the
31 attached document.
- 32 ADOPTED: this 13th day of March 2018 by a vote of 8 for, 0
33 against, and 0 abstentions.
