A BILL

TO AMEND ALL CONDITIONAL COMMITTEE BYLAWS

1 WHEREAS, it is the responsibility of the Judicial Committee to
2 ensure that the Governing Code accurately reflect the
3 policies and practices of SGB;
4 WHEREAS, There are inaccuracies in the Conditional Committee
5 bylaws;
6 WHEREAS, There are multiple grammatical and formatting errors
7 throughout the Conditional Committee bylaws; *now,*
8 *therefore, be it*
9 RESOLVED, on this 13th day of September in the year 2022, the
10 University of Pittsburgh Student Government Board
11 enacts the following revisions to the Student

12 Government Board Governing Code under the short
13 title “Updating All Conditional Committee Bylaws”;
14 *and be it further*

15 RESOLVED, that all uses of the term “Chairperson”, “Chairman”, or
16 “Chair Woman” in any Title of the Governing Code
17 except for Title 3, be replaced by the term “Chair”; *and*
18 *be it further*

19 RESOLVED, that for consistency, Title 2, Chapters 5 and 6 are
20 hereafter named Chapters 4 and 5, respectively; *and*
21 *be it further*

22 RESOLVED, that after careful review and with a focus on
23 consistency and brevity, changes were made to the
24 following sections: Title 2 Chapter 3 Articles 3-6, and
25 Title 7 Chapter 1 Article 5; *and be it further*

26 RESOLVED, that the attached document¹ be the most current
27 version of the governing code; *and be it finally*

28 RESOLVED, that this resolution shall be effective 13 September
29 2022 and shall reflect the changes shown in the
30 attached document.
