A BILL

UPDATING THE GOVERNING CODE

- 1 WHEREAS, according to the governing code, it is the duty of the
2 Judicial Committee to review revise the governing
3 documents yearly, the Judicial Committee proposes an
4 amendment to the Governing Code;

- 6 WHEREAS, the information regarding recommended funding for
7 student organizations outlined in Title 7, Chapter 1,
8 Article 1, Item 3 is inaccurate;
9
- 10 WHEREAS, there is an error on page 10 within the table of
11 contents under Title 5, Article 5, Section 4, Item; *now,*
12 *therefore, be it*

14 RESOLVED, on this [02/04/2020], the University of Pittsburgh
15 Student Government Board enacts the following
16 revisions to the Student Government Board Governing
17 Code under the short title Updating the Governing
18 Code; *and be it further*

20 RESOLVED, that Title 7, Chapter 1, Article 1, Item 3 shall now
21 read:

22 A. Student Government Board has recommended that the
23 following student organizations' budgets be allocated
24 based upon the following percentages of the Student
25 Activities Fee: 1. WPTS-FM Radio: 5.0% 2. Pitt Program
26 Council: 26.9% 3. PittServes: 7.4% 4. Student Office of
27 Sustainability: 0.30% 5. Student Government Board: 1.4%
28 6. The Pitt News 2.0%

29 B. Student Government Board may recommend changes to
30 the above percentages when deemed necessary.

32 The line which states: "A. The Judicial Committee
33 specifically may not find a defendant guilty of a charge
34 different than the one on which they were originally found
35 innocent by the Elections Committee" shall be removed from
36 the table of contents; *and be it further*

38 RESOLVED, that all numbering changes resulting from these
39 revisions shall be automatic, pursuant to the rules set
40 forth in items 1.1.1.0.4 and 1.1.1.0.5 of the Student
41 Government Board Governing Code; *and be it finally*

42 RESOLVED, that this resolution shall be effective immediately
43 upon adoption and shall reflect the changes shown in
44 the attached document.
